TAPE AND WEBBING, TEXTILE, WOVEN REINFORCING, COTTON

The Parachute Industry Association makes this document available for use by Industry and Government organizations that wish to apply this specification to their products.

1. SCOPE

1.1 Scope. This specification covers five types of woven cotton reinforcing textile tape and webbing intended for use in the manufacture of aeronautical equipment.

1.2 Classification. The tape and webbing shall be of the following types, as specified (see 6.2).

Type I	- Plain weave.
Type II	- Double herringbone weave.
Type III	- Twill weave.
Type V	- Plain (transverse cord) weave.
Type VI	- Non-elastic weave.
