Purchasing Factors

Factors that must be considered prior to initiating a contract:

1. Valid Requirement:
 - a. Required to have a valid requirement in place to justify a purchase.
 - b. Requirement can be based on an actual requisition or by a forecast from the Program Manager or Item Manager.
 - c. Forecasting is challenging due to spikes in requirements (changes in training environments, emerging conflicts or natural disasters).

2. Funding:
 - a. Extremely limited and competitive.
 - b. There are only a few sources of funding that can be used for our sustainment contracts (Army Working Capital Funds (AWCF) & Army (OPA).
 - c. We do accept Reimbursable and Direct Cite funding from other services to support their requirements for aerial delivery equipment as well.

Note: Both funding and a valid requirement are necessary to obtain a contract.

Qualified Products List



Qualified Products List (QPL): For personnel parachute procurements, a qualified vendor must be on the QPL for consideration of that procurement. A qualified manufacturer is one who has met the requirements for qualification and whose Manufacturers Cage Code has been entered on the applicable QPL. QPL status must be in place prior to any award pursuant to a specific item solicitation,
